2024-2025 Influenza Virus Vaccine – Call for Requirements /Suspense Date: 22 September 2023

---

### Reason / Information:

The US Army Medical Materiel Agency Distribution Operations Center (USAMMA DOC) in conjunction with Defense Health Agency (DHA) is providing guidance with regards to the data call for the upcoming 2024-2025 influenza requirements.

---

### Disposition / Instructions:

ACTIONS NEEDED:

#### **SUSPENSE: 22 Sep 2023**

- 1) Medical Treatment Facilities (MTFs) are required to provide their Southern and Northern Annual Influenza (Flu) vaccine requirements for the upcoming season 2024 – 2025.
  - a. All Active, Reserve and National Guard Components should plan for 100% mandatory vaccination of service members, as a total force vaccination is expected.
  - b. Request that each MTF coordinate with their respective Installation Public Health Staff, Pharmacy Officer, Logisticians as well as last year's Influenza Point of Contacts (POC) to determine the number of doses needed to meet the requirements. Ensure to review deployment and redeployment schedules. Consider previous influenza vaccine orders, usage, and end of the year waste history, when analyzing how much vaccine to request.
  - c. Retrieve the requirements request form "*Influenza Requirements Form for SH-NH Requirements 2024-2025 Season.pdf*" via the USAMMA DOC SharePoint site/Influenza Vaccine Information:

  - d. Download, save and complete the form. DO NOT complete via weblink.
  - e. Complete the 2023-2024 DoD Seasonal Influenza Requirements Form in doses.
  - f. Submit the form using the submit button. If button does not work email all forms to [usarmy.detrick.usamma.mbx.vaccines@army.mil](mailto:usarmy.detrick.usamma.mbx.vaccines@army.mil)
- 2) Request that each component coordinate with their respective Installation Public Health Staff, Pharmacy Officers, Logisticians, as well as last year's Influenza Point of Contacts (POC's) to determine the number of doses needed to meet the requirements. Ensure to review deployment and redeployment schedules. Consider previous influenza vaccine orders, usage, and end of year waste history, when analyzing how much vaccine to request.
- 3) Follow the ordering form and enter your requirements by the multiple age categories to assist in minimizing the impact of manufacturing problems or shipping delays. Manufacturers may bid and win multiple age categories. Do not try to avoid a particular product by not placing an order in a specific age group.

**NOTE:** The age category 6-35 months (Infant Pediatric Vaccine) should ONLY be considered for children 6-35 months and not assume this age category will cover all age groups.

- 4) The manufacturing contracts have NOT been awarded for next year, and DoD cannot predict who the suppliers will be, based on last year's contracts. The seasonal Influenza Vaccines that may be awarded could include a mixture of Trivalent and Quadrivalent Vaccine. Request that each component coordinate with their respective Installation Public Health Staff, Pharmacy Officers, Logisticians, as well as last year's COVID-19 Vaccine Point of Contacts to determine the number of doses needed to meet any potential vaccine orders.
