Influenza Virus Vaccine Disposition Instructions for season 2022-2023

Reason / Information:

US Army Medical Materiel Agency Distribution Operations Center (USAMMA DOC) would like to provide disposition guidance on the expired and/or expiring 2022-2023 Influenza Vaccine.

Disposition / Instructions:

ACTIONS NEEDED:

In preparation for the upcoming 2022 - 2023 Influenza Vaccine season, Medical Treatment Facilities (MTF's) and Vaccination Sites can follow the disposition guidance listed:

----Option 1: Upon expiration June 2023, destroy all Influenza Vaccine in accordance with local standard operating procedures and/or current regulations. Provide a copy of destruction document to your Service POC.

----Option 2: Upon expiration, unused syringes and/or unopened multi-dose vials can be returned through a pharmaceutical reverse distributor program (i.e., Pharma-Logistics). Provide a copy of turn-in document to your Service POC.
