

United States Army Medical Material Center Europe (USAMMCE)

Influenza 2025-2026

1. DoD Policy. Influenza vaccination is mandatory for all Active Duty, Guard, and Reserve component personnel. Influenza vaccine will be administered in accordance with Service-specific guidelines and immunization regulations. Typically, services are expected to have $\geq 90\%$ of all service members immunized by mid-December.

2. Available Vaccines.

3. Requisition: Customer orders are appreciated early, but must be submitted no later than August 15, 2025, through regular supply ordering channels. These orders will undergo validation against the approved **AFRICOM/EUCOM** influenza forecast for the 2025-2026 season. While awaiting vaccine arrival at USAMMCE, orders will be placed on hold and may be substituted with alternative vaccines from the originally forecasted product based on availability and age categories. The requirements for the upcoming 2025-2026 Influenza season have already been committed under a larger DoD contract, based on the figures provided by the Customer POCs in October 2024. Once specific orders are committed, any reductions will not be possible, and financial responsibility will be based on the original projected quantity.

4. "Distribution: As the product becomes available, customer orders will be released for distribution. **The USAMMCE Customer Service Division (CSD) will send out "PRE-ALERT" emails, which must be acknowledged before release.** USAMMCE expects to receive the influenza product by the end of September, with processing and distribution extending into October. All timelines are contingent upon material arrival, so we recommend not scheduling Flu shot events until you've confirmed material delivery to your location."

5. Cold Chain Management. Influenza vaccines are temperature sensitive. Activities must comply with cold chain management guidelines when receiving, storing and transporting vaccines. Receiving facilities will ensure vaccine handlers are properly trained in vaccine storage & handling. All supply and logistics personnel are strongly encouraged to complete the annual "Seasonal Influenza Vaccine Cold Chain Management for Logistical Personnel" in Joint Knowledge Online (JKO). The course number is DHA-US070.

6. Potentially Compromised Vaccine. If the product becomes potentially compromised due to temperature, the vaccine should be placed **immediately** in a working refrigerator and marked **"DO NOT USE"**. Follow the TempTale instructions included in the shipment and do not assume the vaccine is unusable, do not discard. Contact USAMMCE for further guidance.
